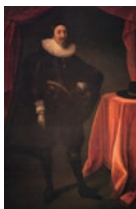

Kiplin Hall was built in 1620 by George Calvert, 1st Lord Baltimore and founder of Maryland, USA. The interior is a fine example of a Victorian country house at the close of the 19th century. The rooms are filled with fine paintings, furniture and personal possessions collected over four centuries by the four families who owned the estate. The Hall stands in one hundred acres of gardens, parkland and woodland, which are undergoing restoration.
